Spaces will be on a first come, first serve basis.

- Check-in will begin at 8:45AM. Vendors may arrive anytime between 8:45AM and 11AM. Vendors will be allowed **15 MINUTES** to UNLOAD their vehicle at their designated space and then move it to Vendor parking. Driving into the festival is for unloading only, set-up of space should be done after vehicle is moved to vendor parking. Golf carts will shuttle you back to event space. **ALL VEHICLES MUST BE REMOVED FROM FESTIVAL AREA BY 11:15AM.** Failure to do so may result in being denied future attendance. Booths **CANNOT** be broken down before 4 PM.
- This is an OUTDOOR event and a "Leave No Trace Event." Exhibitors must supply their own table, chairs, tent, and any other related material and leave designated areas in same condition as arrival. Please come prepared.
- Vendors must give a description of what will be sold or displayed in their booth.
- Booth locations and acceptance are at the sole discretion of the Gibbstown Day Committee. We reserve the right to deny any application. No refunds will be issued once application has been approved.
